


## Learning loss will probably be greater for low-income, black, and Hispanic students.

... and the result is learning loss from student disengagement and/or lack of access





90% of school divisions participating

We provided educators across Virginia a learning management system (Canvas) at no cost.

Expanded course content for K-12 - core content for free

By December we will have asynchronous courses available for K-12

Invested ~\$1M to increase number of VVA teacher-led courses beyond the former 15/high school to 12,000 total enrollments



## **Virtual VA**

The Virginia Department of Education's Virtual Virginia Program (VVA) offers **online courses**, **professional learning** opportunities, and **digital content** to schools, students, and educators across the Commonwealth.



## **Expanded Access in 2020-2021**

Increased — from 6,000 to 12,000 — the number of free student enrollments available to divisions in Virtual Virginia-instructed courses in 2020–2021

Virginia Public school divisions can integrate with the Virtual Virginia learning management system to roster classes and transfer grades

The creation of digital content for grades K–12

A dedicated space within the platform for school divisions to curate, create, edit, and share course content and instructional materials

The expanded access to Virtual Virginia is available at **no cost** to school divisions through support from the federal Coronavirus Aid, Relief, and Economic Security Act, also known as the CARES Act




### Virtual VA: Student Preparedness



#### Are students prepared to take virtual courses?


More than 90 percent of students who responded to the survey agreed that they had the skills necessary to be successful in their virtual course, including time-management skills, responsibility, and self-direction (see Figure 1). Survey responses from staff at participating schools align with this finding. While staff identified students' use and development of soft skills as the most common barrier to virtual learning, only 14 percent of staff agreed that it was moderately or very difficult.

### More online learning...

- 88% of students stated that they would take another online course.
- 95% of staff indicated that they were satisfied with the Virtual VA program which created a positive online experience.

#### Would students take another Virtual Virginia course?

Eighty-eight percent of students reported that they would be comfortable taking another online course, and 85 percent of parents/guardians indicated that they would enroll their child in a Virtual Virginia course again. Among staff, 95 percent indicated that they were moderately or completely satisfied with Virtual Virginia program, and 95 percent believed students' Virtual Virginia experience created positive attitudes towards virtual learning.

#### **Next Steps**

While participation in the 2019-2020 Virtual Virginia surveys was limited due to school closures, most respondents rated the program positively. The role of virtual education, and the Virtual Virginia program specifically, greatly expanded for the 2020-2021 school year in response to the COVID-19 pandemic. VDOE will revise survey content for the 2020-2021 school year to seek relevant and actionable feedback from students, parents/guardians, and staff on the virtual education landscape in Virginia.

 As specified in § 22.1-212.24.A & B, the Superintendent of Public Instruction will develop, and the Board of Education will approve, the criteria for approving multidivision online providers, including those specified in these sections.



### What is a MOP?

 A Multidivision Online Provider (MOP) is a local school board or a private or nonprofit organization that provides online courses or programs to students in multiple public school divisions in Virginia.



#### **Competitive grants**

Eligible technologies: computing devices, LTE mobile data plans, hotspots, filtering, device management, other technologies that expand WiFi into the community.

Students will get LTE mobile carrier access to the Internet via a hotspot



## OER and Hybrid/Virtual Learning

- The VDOE is serious about supporting teachers to provide student-centered, culturally-responsive teaching, no matter the medium used
- Openly-licensed resources provide a means for teachers to do this easily and quickly
  - Easy editing allows on-the-fly adjustments
  - Digital (can be shared through Internet, downloaded for sharing on USB drives, or printed)
  - Lessons provided need not be the same for each student or group of students
  - New recommended resources can be pushed out to a group immediately
  - No concern about restrictions on flexibility




## #GoOpenVA Capabilities

- Access through single-sign on or direct login
- Access through LTI connections with local LMS and/or Virtual Virginia's Canvas
- Provision of spaces for sharing and collaborating (large or small groups)
- Encouragement of "mentor mentality" among teachers to share what they know with other teachers, helping all with continual growth and exploration of new skills
- Important Note: #GoOpenVA is teacher-facing, meaning it is intended to be used directly by teachers. Although there are student-facing resources linked, and students can access these, it is not designed as a student-facing system.
