Regional Alternative Education Center Boiler Replacement (018-117-00-101): The square footage listed is for the boiler room only

Oakland Elementary Boiler Replacement (018-113-00-101): The square foot area listed is the boiler room only

Gladeville Boiler Replacement (018-121-00-101): The high cost is due to the limited square footage of the boiler room.

Laurel Elementary Boiler Replacement (018-116-00-101): The high cost is due to the limited square footage of the boiler room.
