SUBJECT: Student Attendance in the 2022-2023 School Year

The intent of this memorandum is to clarify the options available to school divisions in determining the attendance of students receiving remote instruction for the 2022-2023 school year as school division staff prepare to close out their attendance reporting for the year.

Consistent with the guidance provided to school divisions in <u>Superintendent's Memorandum</u> #230-21 dated August 18, 2021, each school division's attendance policy should articulate what constitutes "in attendance" otherwise known as "meaningful engagement" for remote instruction days. Students are then counted as present or absent in accordance with that policy for any remote learning day. Examples of what might be included in the attendance requirements for various instructional delivery models are provided below. As background, this chart was originally included in <u>Superintendent's Memorandum</u> #188-20 dated July 24, 2020.

Please note that school divisions' attendance policies may include different requirements for remote instruction than what is provided in the chart. However, the requirements for attendance included in the division's policy should be used to determine whether a student receiving remote instruction should be considered present or absent.

Student attendance data are collected through the end-of-year (EOY) Student Record Collection (SRC) which is due July 14, 2023, with final verification due to the Department by July 21, 2023. A school division can continue to update 2022-2023 school year data if they have not submitted final verification. If a division has completed the EOY SRC verification process and needs to make changes, contact Brittney Kanard in Data Services at Brittney.Kanard@doe.virginia.gov to reopen the data collection window.

Please be aware that the guidance included in this memorandum is not applicable beyond the 2022-2023 school year. Additional guidance regarding attendance requirements for 2023-2024 and beyond will be provided in a subsequent communication.
