SUBJECT: 2016 Virginia Fine Arts Leadership Conference

The Virginia Department of Education, in collaboration with the Virginia Coalition for Fine Arts Education, is co-sponsoring the Fine Arts Leadership Conference for fine arts K-12 administrators and specialists. The conference will be held on May 24, 2016, 9 a.m.-3:30 p.m. at the Warehouse Theatre, Academy Center for the Arts, 600 Main Street (theatre lobby entrance on Sixth Street), Lynchburg, Virginia.

The conference will be directed through the following three conference thrusts:

- Vision and leadership;
- Emerging programs; and
- Strategies for success.

The purpose of the conference is to provide professional development for fine arts leaders to improve and strengthen programs in dance arts, music, theatre arts, and visual arts.

Session speakers include Dr. Steven R. Staples, superintendent of public instruction, Virginia Department of Education; Geoffrey Kershner, executive director, Academy Center of the Arts and founder, Endstation Theatre Company, Lynchburg, Virginia; and Jeff Poulin, arts in education program manager, Americans for the Arts, Washington, D.C. Session speakers will present information on a number of critical fine arts educational issues, including community involvement/partnerships, STEAM, educational policy, fine arts integration, and effective advocacy. Breakout sessions are also planned to afford participants opportunities to discuss and share relevant information and best practices both within and across fine arts disciplines.

The Virginia Department of Education encourages each school division to send a fine arts representative(s) to this informative and important conference. Conference registration is offered at no cost to public sector employees and includes a morning break and boxed lunch.
