Dr. Andy Armstrong, Assistant Superintendent of Strategic Innovation, presented this item to the Standing Committee. Dr. Armstrong updated the Standing Committee regarding the completion and compliance of the College Partnership Laboratory School Application for Germanna/Future Educators Academy, a laboratory school proposal from a collaboration between Germanna Community College and school divisions in Culpeper, Orange, Madison, Clarke, Fauquier, Frederick, Page, Rappahannock, Shenandoah, and Warren counties, and the city of Winchester. Representatives from Germanna Community College were in attendance.

Mr. Bailey made a motion to approve the application for first review and release for the public comment period. The motion was properly seconded and carried unanimously. Ms. Wodiska requested that the VDOE post the application for a ten-day public comment period in accordance with the Standing Committee's procedures.

# B. First Review of College Partnership Laboratory School Application from University of Mary Washington

Dr. Andy Armstrong, Assistant Superintendent of Strategic Innovation, presented this item to the Standing Committee. Dr. Armstrong updated the Standing Committee regarding the completion and compliance of the College Partnership Laboratory School Application for Academy of Technology and Innovation at University of Mary Washington, a laboratory school proposal from a collaboration between University of Mary Washington and Stafford County Public Schools as the fiscal agent and hiring agent, as well as the four other school divisions in Planning District 16: Caroline County, Fredericksburg City, King George County, and Spotsylvania County.

Ms. Wodiska noted that she and Dr. Armstrong had the opportunity to visit the University of Mary Washington to provide some additional technical support on the application and viewed the facility that will house the Laboratory School.

Dr. Moran made a motion to approve the application for first review and release for the public comment period. The motion was properly seconded and carried unanimously. Ms. Wodiska requested that the VDOE post the application for a ten-day public comment period in accordance with the Standing Committee's procedures.
