SUBJECT: Rural and Low-Income School Program Symposium

The Department of Education is pleased to announce the Title VI, Part A, Subpart 2, Rural and Low-Income School Program Symposium in collaboration with the Title III, Part A, Limited English Proficient (LEP) Program, and the Title I, Part C, Education of Migratory Children Program. This symposium is designed for practitioners and administrators employed in rural school divisions. *Collaboration and a Common Language for Educators of English Learners (ELs)* will be presented by Dr. Margarita Calderon and associates. The focus of this training will include the following:

- 1. Collaborating to develop a common vision and common language for educating ELs
- 2. Collaboration begins with interaction strategies
- 3. Building relationships for collaboration
- 4. The socio-emotional foundations of collaboration
- 5. Co-teaching: ESL, content, and special education teachers
- 6. Collaborating with Coaches and Peer-Coaches
- 7. Teacher-Administrator collaboration
- 8. Working in Teacher Learning Communities (TLCs)
- 9. Observation tools for self-reflection, peer-coaching, coaches, and administering walk-throughs

This symposium will be held at The Hotel Roanoke and Conference Center, 110 Shenandoah Avenue, Roanoke, Virginia 24016, September 10-12, 2014. Registration will be from 11 a.m. until 2 p.m. on Wednesday, September 10. The symposium will commence at 1 p.m. Wednesday, September 10, and conclude at 1:30 p.m. Friday, September 12. School divisions in receipt of Title VI, Part B, Subpart 2; Title III, Part A; and Title I, Part C, funds are invited to send coordinators, teachers, and other division instructional representatives to this symposium.
