## **SUBJECT: WIDA 101: Introduction to English Language Development (ELD) Standards and Assessments Workshop**

As part of the Virginia Department of Education's ongoing effort to ensure compliance with Section 3111(b)(2) of the *Elementary and Secondary Education Act of 1965* (ESEA), a one-day workshop titled *WIDA (World-Class Instructional Design and Assessment) 101: Introduction to English Language Development (ELD) Standards and Assessments* will be held at the following sites on the specified dates below:

This workshop will provide an overview of the ELD Standards framework and accompanying assessments. Educators of English Language Learners (ELLs) with little or no experience with ELD Standards and assessments are encouraged to attend. Participants will:

- Learn about WIDA's theoretical foundations and student-centered focus;
- Explore the connection between academic language and the five ELD standards, as well as their representation within the four language domains;
- Understand the structure of the standards framework, discuss the six levels of language proficiency and their performance criteria, and learn the elements of model performance indicators (MPIs); and
- Examine the relationship between MPIs and test items, as well as the basic structure of assessments for ELLs.
