SUBJECT: **2021-2022 Federal Program Monitoring for Certain Programs under the *Elementary and Secondary Education Act of 1965*, as Amended**

The *Elementary and Secondary Education Act of 1965* (ESEA), as amended, requires states to monitor school divisions for compliance in certain program areas. The purpose of this memo is to share with school divisions information about federal program monitoring for the 2021-2022 academic year for the following programs: Title I, Part A, Improving Basic Programs Operated by Local Educational Agencies; Title I, Part C, Education of Migratory Children; Title I, Part D, Prevention and Intervention Programs for Children and Youth who are Neglected, Delinquent or At-Risk; Title III, Part A, Language Instruction for English Learners and Immigrant Students; and Title V, Part B, Subpart 2, Rural and Low-Income School Program. School divisions and federal programs that will be monitored during the 2021-2022 school year are listed in **Attachment A**. The type of monitoring that divisions and programs will receive is available in **Attachment B**. The full five-year monitoring schedule is available in **Attachment C**.

In preparation for monitoring, the Office of ESEA Programs offers technical assistance to school divisions. Program specific webinars will be held according to the schedule below. School division federal program coordinators are encouraged to participate in the program-specific webinars, as applicable. The specialists for Title I, Part C and Title V will contact the school divisions and programs being monitored this year to set up individual federal program monitoring conference calls. School division federal program coordinators will be provided

access to the monitoring documents on the [Federal Program Monitoring](#) website before the scheduled webinar dates.
